Pay initially \$13 per hour, will increase to \$15 after six months. Bio should be in the UU-connect this week, and again in the Order of Service.

payback will be about \$660 with changes. Parking Lot - grounds master planning meeting brought up conversation about expanding parking area, best use of space, city considerations, tree removal, need to re-pave in next couple of vears. Basement Reno - Per Michael, Carl B thinks small side of basement could be done for about \$1K. Michael P currently programs thermostats manually each week; will continue until WiFi can be linked via Honeywell to automate. Katina & Karen emphasize that gbauuf.com emails should be used for these communications. Front GBAUUF sign light - half is not lit; Creative Sign had won the bid; need to call vendor to investigate. Michael will call them to get repair estimate. May have looked at sign previously, approximately September of 2017. Finance Church Mutual Insurance is restructuring; more details to come. Need ways to bank money for future fiscal years' needs such as AV,, remodeling, capital projects. If not used, can funds be rolled over to next year? Women's retreat did not use up

all of allocated funds. Finance Committee tasked with looking into rollover of funds - Janice will contact treasurers with request. Or possibly start a fund for member emergencies (Chalice Lighters)? Canvass 2020 - Katina D. Endowment option added; biggest change is to Time / Talent / Interest Form Added lines regarding board openings, committees. Two new sections, ongoing cadres, SCRIP sellers, summer grass cutters, etc.; section for strategic tasks; follow-up needed. On-line or paper. Launches this Wed. in UU connect. Four people speaking at Sunday services regarding canvass. Administrative Google Voicemail - For urgent needs, calls will be directed immediately to the Chairperson's phone number. Pam F has used the new Announcement procedure. Community Assistance Folder could have stash of gift cards, etc., to help the needy (food, gas cards, small denominations, not cash); also a list of resources available (food pantries, shelters). Katina suggests posting something on front door. Amy B offered to put together resource list, and initial plea for stocking campaign.

Facilities Update - Michael Paprocki

01/07/20 - The peanut butter in the traps is no longer being eaten. Perhaps we have caught the last mouse. Picked up the secondary doorbell push button from Home Depot.

01/08/20 - Changed the receptacle in the first R.E. Room. It had been broken, apparently during prior installation. Carl picked up a supply of one of our furnace filter types (for furnace [#3] - the Sanctuary).

01/09/20 - Changed the broken cover on the switch for the kitchen lights.

01/10/20 - Talked to Steve Gruselle about the trails of snow left between plow stokes and the damage to the back lawn. I understand he has signed a contract with us. He seemed a little upset with me. I suspect perhaps he is of late getting information and direction from both myself and Karen Eckberg, and he's not sure who to listen to. Karen and I really need to decide which of us is going to be in relationship with him. Update 01/25/20: It is my feeling that we should have asked that salt be applied for Sunday the 25th, but I am reluctant under the circumstances to speak with Steve about it.

01/11/20 - Put in boundary markers in the back parking lot to mark the boundaries of the lot.

01/12/20 - Changed the 3-way switch in the East Basement Storage Room. Carl brought in the filters for the two smaller furnaces (Basement [#1] and West End Offices [#2]). He installed the two small furnace filters. I reset those two furnaces' thermostat's filter change timers.

01/16/20 - Chip summited the Focus on Energy application for incentives on the new furnaces.

01/24/20 - Installed the lock on Utility Room door. Notified O&C staff; no longer need to check Storage Room or Utility Room to close the Fellowship. Started removal of automatic door closer on Storage Room.

Update 01/25/20 - Finished removing automatic door opener on Storage Room door.

01/26/20 - Finished testing front parking lot pole light. It's working fine. Turned it back on permanently.

01/28/20 - Finalized the "function" settings on the Sanctuary and Office thermostats. Turned their WiFi capabilities back on. Need yet to set the Basement thermostat.

02/03/20 - Sent in Facilities Report for February Board meeting.

MEMORANDUM OF UNDERSTANDING Building Unity Tour

<u>Building Unity Tour</u> is a <u>35-week</u> tour aimed at supporting voter education, activation, and registration. Tour-stops may include community gatherings, entertainment, food, volunteer activities, education, and family-friendly fun and creativity. Tours will occur on Saturdays, Sundays, or both, and will bring people from other parts of the state to each scheduled stop. Activities will support local residents to increase participation in our democracy through promotion of voter registration and education about important issues related to peace, justice, sustainability, and democracy.

Building Unity Tour -- Partners:

Building Unity Tour – Partners (BUTPs) are organizations, networks, other projects and campaigns, and individuals that:

- 1. share our goals to increase accessibility to voting for all Wisconsin citizens, and
- 2. share our goal to promote world peace, social justice, environmental sustainability, and participatory democracy by supporting an informed and active electorate.
- 3. believe that all eligible voters should be able to vote.
- 4. are willing to support **non-partisan** voter education and engagement in communities throughout Wisconsin.

By signing this MOU, BUTP's agree to work with other project partners to promote voter education,

engagement and registration through the Building Unity Tour, and will do this work in a *non-partisan* way that supports the guiding mission, purpose, and general policies of this project:

1. Mission

Voting is not only a right, but a responsibility in a democracy. We seek to eliminate barriers to voting and to maximize voter participation in the electoral process.

2. Purpose

Building Unity Tour will promote, support, and encourage people to vote.

3. Publicity

Only members of the Building Unity Tour – Steering Committee (BUTSC) may speak on behalf of the project as a whole, and they will do so only after consulting at least two other members of the Steering Committee. Other volunteers with the Building Unity Tour are encouraged to identify themselves as "working with the Building Unity Tour"

4. Leadership

- 1. Partnering organizations are encouraged to provide one representative to serve on the BUT Steering Committee. The BUTSC will make decisions by consensus.
- **2.** Local participation and leadership in planning Building Unity tour-stops is essential.
- 3. The leadership, views, and contributions of all Building Unity Tour Project Partners will be valued and supported.
